County Touchpoints in Access to Medications for Addiction Treatment for Justice Involved Individuals

Module 5. Overcoming Barriers to MAT

Module Overview

This module offers a 14-minute video in which stakeholders in criminal justice reflect on how they overcame skepticism about the use of MAT in jails and probation, and their experiences with using it. It includes commentary from two persons with Opioid Use Disorder (OUD) who received MAT. Supplemental materials provide evidence-based responses to the most common objections to MAT both generally and in justice settings. Discussion questions are provided to help participants translate this information into action in the workplace.

Content

- Video “MAT in Justice Settings” – funded by California Health Care Foundation, produced by Health Management Associates, 14 minutes. Interviews with two large jail administrators, county public health director, jail physician, jail nurse, probation director, probation officer, jail behavioral health director, and sheriff who share perspectives on using MAT, and transitions from skepticism to varying degrees of acceptance. Includes comment from two clients with OUD who use MAT.
- Document “MAT for Opioid Use Disorder: Overcoming Objections” created with input from many justice stakeholders involved in the Jail MAT project, many experts in SUD treatment and opioid addiction, and several physicians who prescribe MAT. Research provided by California Health Care Foundation. Document provides most common objections to MAT and evidence-based responses.

Facilitator Steps

1. Print and distribute Module Overview, Learning Objectives, and the document “MAT for Opioid Use Disorder: Overcoming Objections” to participants as they enter the room.
2. Distribute the pre-test questions to participants and have them complete it. Then discuss the responses
3. Review the Module Overview, Learning Objectives, and MAT document
4. Show the video.
5. Following the video, have participants discuss reactions in small groups. No need to structure the discussion. Ask the participants for comments on the chief points of discussion.
6. Refer to the document “MAT for Opioid Use Disorder: Overcoming Objections.” Ask participants to share objections they have had themselves (or still have) or have seen expressed by others to MAT.
7. Discuss the evidence-based responses; seek to get participants comfortable verbalizing the responses in their own terms. Need not cover every single issue; read the group and focus on the most significant issues.

8. Provide an opportunity for any further questions and discussions
9. Distribute post questions, capture responses in accordance with CEU requirements and then discuss responses

Learning Objectives

At the end of this session, the participant can:

1. Name at least three common objections to the use of MAT that you experience in your work.
2. Provide evidence-based responses to each of the objections.
3. Describe one example of how persons who have used MAT describe its effect on them.

Pre-Test Questions

1. Providing MAT in jails is generally too difficult to safely accomplish. True/False Correct answer: FALSE
2. Stopping MAT for incarceration or to participate in drug court treatments can contribute to the risk of relapse, overdose and death. True/False Correct answer: TRUE

Post-Test Questions

1. Using methadone or buprenorphine for a brief period during detox is safe and effective at preventing relapse and overdose. True/False Correct answer: FALSE
2. A person who has strong objections to MAT may change his mind about it based on knowledge and data. True/False Correct answer: TRUE
3. There is strong evidence that using MAT reduces cravings, which allows people with OUD to think clearly and engage in treatment. True/False Correct answer: TRUE


